# **TECHNICAL RULES**

## **1 COMPETITION RULES AND REGULATIONS**

- 1.1 The Boxing events at the 4<sup>th</sup> Islamic Solidarity Games, Baku 2017 shall be conducted in accordance with the latest edition of the following document that is in force at the time of the Games:  
The International Boxing Association (AIBA) Technical and AIBA Open Boxing (AOB) Competition Rules  
- Rules, available at [www.aiba.org](http://www.aiba.org).
- 1.2 For technical matters, the AIBA Competition Rules and Regulations are binding.
- 1.3 For general matters, ISG Basic Regulations, General Rules and this Technical Handbook should be consulted.

## **2 COMPETITION MANAGEMENT**

- 2.1 The Boxing competition shall, under the authority of the ISSF, be organized by AISGOC, in conformity with AIBA Rules and Regulations and under the supervision of the Technical Delegate.
- 2.2 The Technical Delegate shall be appointed by AIBA.
- 2.3 The Azerbaijan Boxing Federation will appoint suitably qualified National Technical Officials who will be approved by the Technical Delegate.

## **3 VENUE AND SCHEDULE**

- 3.1 The Boxing competition shall be organized at Crystal Hall, Baku, Azerbaijan during the period from 12<sup>th</sup> – 18<sup>th</sup> May 2017.
- 3.2 Training venues will be prepared for the participating teams according to a schedule made by the Organizing Committee and distributed prior to participation.

## **4 TECHNICAL MEETING**

- 4.1 The Technical Meeting will be held two days prior to the start of competition, currently scheduled for 10<sup>th</sup> May 2017.
- 4.2 The meeting shall be attended by:
  - Technical Delegate
  - Two members of each participating team (Official and Coach).
- 4.3 The meeting aims at providing the necessary information on the progress of events as well as the explanations related to the implementation of the Rules of the AIBA and the provision of the sport Technical Regulations.

## **5 EVENTS AND PARTICIPATION**

- 5.1 National Federation must be an affiliated member of AIBA.
- 5.2 Athletes must hold the nationality of the country from which the NOC is registered. For eligibility, only individual passports shall be used as the official document of the athlete.
- 5.3 Athletes must be registered with AIBA.
- 5.4 Each NOC has the right to participate with a maximum of one (1) boxer per weight category.

Events are as follows:

1.	Men's Light Fly (49kg)
2.	Men's Fly (52kg)
3.	Men's Bantam (56kg)
4.	Men's Light (60kg)
5.	Men's Light Welter (64kg)
6.	Men's Welter (69kg)
7.	Men's Middle (75kg)
8.	Men's Light Heavy (81kg)
9.	Men's Heavy (91kg)
10.	Men's Super Heavy (+91kg)

5.5 The maximum number of boxers per NOC delegation is 10.

5.6 It should be noted that for Boxing there are no pre-qualification standards.

5.7 All competitors must be of age between 18 years and 40 years (born between 11.05.1999 – 20.05.1977) which is determined by AIBA Technical Rules 1.1.6. and 1.1.6.1.

5.8 The Composition of the official delegation will be in according to the following:

#### **Annotations:**

- All referees and judges will be appointed by AIBA. AISGOC will review arrangements for National Federation Referees and Judges with AIBA.
- All Boxers must bring the following items to the General Weigh-In:
  - International AIBA Competition Record Book with an annual medical certificate issued by a Medical Doctor
  - Valid passport
  - Accreditation card

## **6 COMPETITION FORMAT**

6.1 The Boxing competition will be run in a standard single-elimination format in all weight categories. The winners of the semi-finals in each weight category will compete against each other in the gold medal contest; the losers of each semi-final will be awarded bronze medals.

6.2 There is no repechage system. When a boxer is defeated they cannot compete again in the same competition. Bouts shall consist of three (3) rounds of three (3) minutes each for men.

## **8 EQUIPMENT**

- 8.1 AISGOC shall provide the competitions equipment in accordance with the AIBA Rules.
- 8.2 AIBA will advise its licensed boxing gloves and hand bandages, to be provided to all athletes for all bouts, and these will be distributed through AISGOC. The gloves are compulsory official items which all athletes must wear. Athletes will not be allowed to wear their personal gloves.

## **9 APPAREL**

- 9.1 Each athlete must bring two sets of uniform (complete red and blue colour sets without mixing of other colours). Uniforms must be in compliance with AIBA Technical Competition Rules.
- 9.2 Athletes must wear a same colour set of either red or blue form fitting vest and shorts as per the athletes' respective corner allocation which will be their own responsibility.

## **10 MEDALS, DIPLOMAS AND VICTORY CEREMONIES**

- 10.1 Victory ceremonies shall be held directly following the end of each competition final. Winners shall wear their training suits or the official Apparel of their National Olympic Committees.
- 10.2 Winners in boxing competitions shall be awarded the following prizes and diplomas:
  - The first place: a gold medal and flower
  - The second place: a silver medal and flower
  - Co third place: bronze medals and flowers for each
